5	Affordable Housing BP concerned that Waverley Council has very little affordable housing, and no published plan for its provision, or for social housing.
	Concern was raised that new building developments are all 'luxury' apartments
	Liberals on Waverley Council have a casting vote – and have 'kicked off' net loss of density, but Councillors continuing conversation with the mayor on DCP and LLP – to fight for affordable housing at some level

	Recently there have major floods in many streets within the precinct. It is recognised that not everything can be resolved by engineering, but flooding is getting worse especially with the torrential rains of recent times.

BP attendees communicated examples of flooding instances in the precinct, including: Need to sand bag an area near a Fish and Chip shop in Blair Street – Cr Merten will follow this matter through with Sydney Water and Waverley Council Francis street flooding problems of water leakages, and drain overflow covers in Francis
	street blowing off – posing serious danger to people – agreed needs a long term solution. The sunken drain system near 60 Francis street was mentioned.
