What does it mean to be a Waverley Council Family Day Care Educator?

Since 1974, Waverley Council has run a local Family Day Care service which is a network of self-employed educators providing quality early education and care their own home.

Waverley Council's Family Day Care has a Coordination Unit who regularly visit, mentor and support educators – helping them to provide full time and part time care according to families' needs. The Coordination Unit also provides playgroup sessions so educators and children have the opportunity to meet and learn with others.

All our Educators are located throughout the Eastern Suburbs and City Fringe.

Waverley Family Day Care is licensed by the NSW Department of Education and complies with the Early Education and Care Services National Law Act 2010 and Regulations 2011.

What is expected of educators?

Educators must comply with all legal requirements, including:

- Education and Care Services National Law Act 2010 & Regulations 2011, Work Health and Safety Act 2011 & Regulations 2017
- Child Protection & Child Safe Standards
- Family Assistance Law & CCS funding agreements
- Waverley Council Educator Service agreement, policies and procedures.

Educators ensure the wellbeing of children by:

- maintaining a healthy, safe and stimulating environment
- ensuring the safety, health and well-being of every child in their care and placing the child's needs first.

Educators are team members by:

- working co-operatively with the Waverley FDC team to ensure the best outcomes for children and their families
- keeping up-to-date with service practices
- actively participating in service activities as appropriate.

Educators conduct their professional early education business by:

- acting in an ethical and professional manner
- attending training and being committed to professional development
- ensuring ongoing consultation with families in relation to their children.

How to start your business

First, get your paperwork sorted

Fill out your application form and send it to the Waverley Family Day Care Coordination Unit with the supporting documentation – see the checklist below.

Next, a site visit and interview

If successful, the Coordination Unit will visit your home to assess your suitability as an educator, and whether your home is appropriate.

Training, insurance and final details

We ask that you visit a current educator, and attend a play session before your registration is finalised. There are also training sessions to attend through Waverley Family Day Care.

You will need educator insurance before your new business can start.

Getting started checklist

Send these documents to the Coordination Unit:

- completed application form
- personal and professional references
- 'Working with Children' consent forms

With copies of your:

- proof of completion of Certificate III in Children Services
- current first aid certificate if available (must be provided before you start)
- Child Protection training certificate
- WHS certificate
- Safe Food Handling certificate

For rented premises only:

- a letter from your landlord giving permission for Family Day Care to be undertaken on the premises

Role of the Coordination Unit

The Coordination Unit are here to help you deliver the best service you can to families.

We do this by providing assistance:

- to meet regulatory requirements – health and safety checks, training, information and resources, policies and guidelines
- with the National Assessment and Rating process & Self-Assessment
- with administration – forms, contracts, Child Care Subsidy (CCS), enrolment, interviewing of families, record keeping
- with running a business – advice, information, contractual arrangements, fees, payment statements
- personal and telephone support
- placement of children
- alternative care for when you take a holiday and other service closures
- with conflict resolution and mediation of disputes
- networking with educators and other child care professionals
- ongoing training
- children’s play sessions and activities
- professional advice on child care issues
- and access to resources.

Setting your daily fee

The cost of Family Day Care varies as educators set their fees independently. However, as a guide, there is a recommended fee determined each year by Waverley Council, in consultation with all stakeholders.

The aim is to provide high quality affordable early education and care for families, while enabling educators to earn an appropriate income.

Do families get assistance with their fees?

Many parents receive help for the cost of care through the Child Care Subsidy (CCS) provided by the Family Assistance Office (FAO).

The Coordination Unit help to administer these entitlements to the families.

Administration Levy

A small daily fee is charged to the educator for contribution to the service.

Placement of children

Families needing care apply online through MyWaitlist. If their request for care is 'matched' to an educator with a vacancy, the Coordination Unit consults the educator about the suitability of the placement and notifies the family.

The family arranges an interview at the educator's home, and both parties then decide if they will proceed.

The family is then interviewed and enrolment takes place at the Waverley Council Coordination Unit.

How many children can you care for?

You may care for up to four children, (including your own), aged 0–5 years.

Hours of care

As an educator, you choose the hours you work – generally during business hours.

Tax and insurance

As a self-employed person, you are responsible for paying your tax, and for keeping your own records of income and expenditure.

Many educators use an accountant to ensure they receive the full benefit of eligible tax concessions and deductions.

Educators must have public liability insurance, which is a protective measure, covering you in the event of a third party suing for damages arising out of negligence. Family Day Care Australia offers comprehensive public liability insurance, which covers you while you are working as an educator at any location.

If your home is rented and the landlord would like extra coverage, Family Day Care Australia can help.

Educators may also like to consider income protection and superannuation.

Start up costs

It is hard to estimate set up costs as some premises need more changes than others to meet safety requirements. However, the following costs should be taken into account:

- public liability insurance through Family Day Care Australia
- fire safety equipment
- first aid kit
- first aid training or refreshers
- Working with Children checks and National Police Check for all adult household members
- protection for non-safety glass – barriers, film or replacement in education and care areas
- safety aids – locks, safety catches, poweroutlet plugs, barricades
- safety switching on power circuits
- resources and play equipment suitable for a varied age group.

Safety in the home

All homes must meet Waverley Family Day Care health and safety standards. Fire safety equipment and a First Aid Kit are some of standards required which will be further discussed during the home inspection. Educators must obtain a current accredited certificate in first aid, asthma and anaphylaxis.

Qualifications and training

Educator training

Waverley Family Day Care policy requires that educators have obtained a minimum Certificate III in Early Childhood Education and Care.

This qualification teaches you how to care for children, nurture their development and make sure their environment is safe and supportive.

TAFE NSW run a variety of related courses, including Certificate III in Early Childhood Education and Care.

Additional help to prepare for your new position as a Family Day Care educator is given individually and through group sessions, covering the following topics:

- role of educator, staff and families
- regulations, policies and practices
- work health and safety
- administration and accountability
- child development
- education program and routines
- art, creativity and resource ideas
- family partnerships.

Regulations & National Quality Framework

The Education and Care Services National Law 2010 & Regulations 2011 set out the minimum requirements for FDC services and educators. Prior to starting you will receive a copy of the Law & Regulations which will be explained to you.

National Quality Framework

Waverley Family Day Care and our registered educators participate in the National Quality Assessment and Rating Process through an evaluation against the National Quality Standards. A system of

continuous improvement through self-assessment requires setting goals for the improvement of each service, and the FDC service as a whole.

You will receive a copy of the Waverley Family Day Care Policy and Procedures Manual, for your information, and for the information of families attending your education and care service.

Family Day Care Australia is the peak body representing the interests of Family Day Care communities throughout Australia.

They undertake advocacy on national issues, and product development. They produce a magazine, Jigsaw, to keep educators and staff up to date on the issues and manage the National Insurance Policy and the Legal Cover Plan.
