# Adoption of minutes of previous meeting - 9th October 2024

## Charing Cross Upgrade

- Nick Prell (Acting Senior Project Manager Waverley Council), via video-link, expressed Council's appreciation for the community's patience, and advised:
- Works south of Carrington Road will be complete by Christmas (trenching and pillars
- 7-10 days prior to Christmas will see a significant reduction in activity
- Demobilisation on 19 December
- 4 weeks of no construction
- Carrington Rd is state-owned therefore, there are limitations and complexities with access and changes (must be done at night)
- Transport for NSW requires ON works
- New year? Jan- Feb: similar state of work
- Feb Ausgrid will commence removing cabling to put it underground
- Ausgrid complexity due to industrial action
- Compliance officers have been no-shows due to industrial action the progress is contingent upon their ability to certify stages of progress
- Trees, curbs, and pedestrian crossings are on schedule

- Civil works will start south end of the site (Albion St and Bronte Road intersection)
- Electrical at the north end of the site (Carrington and Bronte Rd intersection
- Road narrowing is to proceed confirmed
- No left turn at Robin Hood the slip lane will be removed, and the radius is too tight for a left turn
- Traffic will be redistributed down Victoria Street and Edmund Street
- Macpherson and Carrington Road are very short light phases
- NB Carrington Road is a state road-
- Albion to Bronte where does the narrowing commence? How will the RH turn traffic be managed?
- Lane width will be narrowed no loss of lanes
- Buses v local traffic road categories different statutory width
- Phasing on Carrington / Bronte / Victoria St Dept of transport
- Dept of Transport deals with the intersection remove the arrow and speak with Marjorie O'Neill
- Stage 2 no date set (first or second week subject to contractor)
- Includes all finishes presented in concept plans
- Tentative completion is Christmas 2025, but the likelihood is of a 2026 finish with 4-6 weeks of shutdown over Christmas
- 5.3 mill + everything around the intersection
- Total spend is appx 7.9 million
- Stage 3 will follow

# War Memorial Hospital Update

- Wentworth Courier article reports 300 apartments (up from 220)
- Residents were unaware or didn't understand that they were going to be ousted to make way for the development

Men's Shed:

- This is the only Men's Shed between the East and Botany
- Councillor Catherine Westwood said the loss is temporary 3-4 years
- Randwick Council potential for co-location
- Bundock St option
- Wayside Chapel option (too small but possible in an emergency)

- Application with State govt has not yet been lodged
- Community display occurs after application
- Bridgit = two weeks' notice only generally at Xmas this is the most difficult time of year to arrange responses

- New aquatic centre, etc.
- Barry and Byron live in the Langlee (the old bowling club)
- Huge impact on Henrietta Street
- Huge impact on the Birrell Street pedestrian access to Waverley Park
- Body Corp cannot take action; it must be an individual
- Implications of college submissions must address the impacts
- Note the 15–20-year duration of the project
- NB traffic impact
- Heavy vehicles + plant and machinery on a narrow, one-way street
- No detail on the mechanism for project management
- Limited detail on quantum and construction plans for buildings
- The future plan involves entry and exit into Henrietta an increase in traffic on Henrietta
- Currently, traffic enters via Henrietta and exits via Birrell
- Massive excavation work planned for the area where tennis courts are retention tank planned for underground threatens the heritage-listed fig tree which is subject to a protection order by Council
- east of the courts on the college grounds arching over Henrietta Street
- The plans acknowledge the risks to the tree
- The tank is intended to capture stormwater but can be relocated
- Note there is no master plan
- The exhibition and consultation period was this year (March to November)
- Mora suggests a WC rep comes to the next meeting to explain the process
- Danny notes the parallels with St Catherine's
- Explained the process of community action to manage the collective objections
- Submissions closed 21 November 2024
- Council has a representative who liaises with the State govt this person needs to be contacted to advise of CCP concerns

#### High Street Rat Infestation

- Possibly caused by digging on Bronte Road
- Anita George has a garage on High Lane and made a submission on 21 November, ref 2428061
- Waverley Council noted its response on 21 August with the following advice to Anita and all property owners in the area:

Rat numbers increase when there is an abundance of food and places for them to live and breed. Under NSW legislation, it is the responsibility of owners and residents to prevent rats from harbouring and breeding on their property.

- Residents can help reduce rat numbers by doing the following:
  - $\circ$  Use bins and don't allow rubbish to overflow
  - $\circ$   $\;$  Ensure your bins have tight-fitted lids with no holes or cracks
  - Make sure you place your recycling and rubbish out ONLY on your scheduled collection day
  - Vermin-proof your premises by making sure there are no cracks, crevices, holes or other potential access points
  - Ensure access to cupboards containing food and food preparation materials are blocked
  - Make certain pet food is eaten soon after it is placed out and removed as soon as practicable
  - Ensure your home, shed and yard is free from overgrown vegetation and rubbish. Remember to trim vegetation away from roofs and external walls
  - o Restrict access to water or water sources
  - Engage regular services of a professional pest controller.

Council undertakes baiting in and around Council facilities. In certain circumstances Council will consider engaging professional pest controllers to conduct baiting on public land.

Your message about rats has been recorded in our request system as feedback.

# Legion Club Mobile Telephone Transmitters

- Mobile transmitters are emblematic of the privatised benefit of public costs: a landowner receives rental payments, notwithstanding the generalised public impact
- It was noted that regulation is a Commonwealth not local government area of responsibility and that areas must be zoned to carry a transmitter
